**SWC Financial & Match Report FY2015:** Dale moved and Harry seconded the motion to approve Herman signing the Certification for the FY2015 Financial and Match Report, *the motion carried*.

**Tour:** At 1:40 the group arrived at Mountain Cloud Farm near Clark Fork. Breigh Peterson and Darren Cloud conducted the tour of the farm which provides vegetables to 75 customers on a weekly basis, and also participates in Farmers Market in Sandpoint. They have 2 high tunnels, one of which is on a track and can cover 3 separate areas. They also are raising cattle, hogs, chickens, turkeys, sheep and goats, and at this time are selling pork, turkey, lamb and goat meat.
